Effective Communication for Safety Leaders

Jeff Campbell, a University of Virginia alum, is a consultant with a concentration on effective business communication, and is the Tarheel Chapter luncheon speaker on Thursday, March 1, 2018.

He has a 20+ year history of pairing communication skills to the skillset for environmental health and safety. He has a diversified resume that includes a stint at Maersk, the world's largest container shipping company. While there he worked directly with safety professionals from senior leadership to field supervisors in marine terminals, trucking, ocean shipping, logistics and distribution.

Jeff was a developer and presenter at Maersk's Transportation Safety Course taken by people from HR, Legal, Finance, etc. as well as every person with any responsibility for safety. He holds the National Safety Council's Advanced Safety Certificate and ASSE's Safety Certificate and Executive Safety Certificate, among other training. Today, Jeff is a freelance writer with 27th Character and continues to consider effective safety efforts as a primary responsibility of every organization and a leading indicator of their success.

WHAT PRESENTATION HOPES TO ACCOMPLISH

Effective communications is about achieving results by providing information that matters to others. Safety successes ripple through the entire workplace and ultimately to the customer, but most people can't connect the dots.
