



FFY 2021—4th Qtr.




All Industries Including State and Local Government Based on Calendar Year



Safety and Health Consultation Program

The N.C. Department of Labor has a program to assist small employers, especially those in high hazard industries, to reach their goal of achieving a safe and healthful workplace for their employees. Experienced professional safety and industrial hygiene consultants will identify safety and health hazards in your business or industry, supply recommendations to reduce or eliminate these hazards, and assess your safety and health management program. Our goal is to help your business meet safety and health regulations and develop an ongoing, effective safety and health management program.

In some instances, a return visit may be necessary. For example, the consultant may need to remonitor air quality or verify that hazards have been properly corrected.

Additional Information:

Two types of surveys are available. An employer may request a facility-wide (full-service) safety and health survey or a specific safety and/or health survey limited to only one or more issues.



FY2021 – Fatality Information

- There were 88 work-related fatalities (in all industries)
 - Up from 79 in FY2020, 54 in FY2019 and 49 in FY2018
 - The 88 fatalities included 32 that were related to COVID-19, plus five related to criminal activity. If you remove those two categories, the total drops to 51 for FY2021.

FY 2021 - COVID-19

- COVID certainly impacted OSHNC activities during the year. Here are some COVID numbers for FY2021:
 - 32 "work-related" fatalities reported
 - 45 hospitalizations reported
 - 108 inspections conducted
 - 2442 complaints received
 - » 1306 were considered valid. Nearly all were investigated by letter with a response required from the employer.
 - » 1136 were considered non-valid. Letters were sent for most of these to notify the employer of the complaint and provide them with a list of COVID resources.



COVID Standards

- The first COVID Emergency Temporary Standard (ETS-1) was promulgated by Federal OSHA under 29 CFR 1910.502 and effective June 21, 2021.
 - OSHNC adopted it as a permanent standard on July 21, 2021.
 - On December 27, 2021, Federal OSHA announced they are withdrawing the non-recordkeeping portion of ETS-1, though they are still working on a final rule.
 - The ETS-1 is still in effect in NC. As of 1/5/22, OSHNC has issued (or written) 25 citations under 29 CFR 1910.502, with a total penalty of around \$47k.
 - The most common citations have been for not developing a COVID-19 plan for the workplace and not conducting a workplace-specific hazard assessment.



COVID Standards

- The second COVID Emergency Temporary Standard (ETS-2) was promulgated on November 5, 2021 (as 29 CFR 1910.501).
 - This standard addresses vaccinations, testing, and face masks for employers controlling 100+ employees.
 - Employers must comply with most provisions by January 10, 2022.
 - The standard was initially stayed by the courts, but that stay was lifted by the 6th Circuit Court of Appeals and is set for oral arguments before the SCOTUS on January 7, 2022.
 - OSH State Plan states (such as NC) have until January 7, 2022, to notify Federal OSHA of their intent to adopt.



OSHNC Special Emphasis Programs

§ 95-136.1. Special emphasis inspection program.

(a) As used in this section, a "special emphasis inspection" is an inspection by the Department's occupational safety and health division that is scheduled because of an employer's high frequency of violations of safety and health laws or because of an employer's high risk or high rate of work-related fatalities or work-related serious injuries or illnesses.

Operational Procedure Notice 123V

Subject: Special Emphasis Program for Construction Activities.

A. Purpose.

This Operational Procedure Notice (OPN) establishes a North Carolina Occupational Safety and Health (OSH) Division Special Emphasis Program (SEP) to decrease fatalities related to the construction industry, specifically North American Industry Classification System (NAICS) sectors 236 - 238. This SEP will also focus on hazards associated with operations that involve tower and mobile cranes.

- Serious, Willful, or Repeat (SWR) violations identified on 60.1% of inspections.
- 1.86 SWR violations per inspection
- Average penalty is \$2812 per inspection

50 Str		The victim was struck by a tree, felled by a co-worker, at a customer's residence.
64 Str		The victim was working along a road picking up traffic cones when he was struck by a truck.
79 Str		The victim, an employee of a grading and landscaping contractor, had been unstrapping/unloading logs from a dump truck after hauling them to a sawmill, was found dead with visible injuries, in the vicinity of the truck and a log which appeared had fallen from the truck.
37 Str	ruck by	The victim, an employee who was working in front of a retaining wall, appx. 100 feet wide and up to 10 feet high, was struck by the wall when it collapsed.
56 Str		The victim was carrying product to put into the truck when another employee in the truck started to backup and struck the victim.

49	Fall	The victim was found on the ground after falling 25 ft. from a roof after working on gutters; the downspout in his hand touched a power line and caused him to fall. The probable cause of death was listed a multiple blunt force injuries.
47	Fall	The victim was engaged in the construction of a garage, working from a ladder and piece of 2x6 lumber, fell and struck his head on the concrete surface below.
40	Fall	The victim, was raised in a basket by a boom truck to a wall (form work concrete) being constructed; he fell to the ground while transferring from the basket to the wall.
38	Fall	The victim was on the roof replacing shingles on a house when he fell off the roof and was impaled on a stair rail.
38	Fall	The victim fell from a two-story roof on a home under construction.
38	Fall	The victim was handed a bundle of shingles to pass to a co-worker on the roof, while on a 4 ft. high scaffold. He fell from the scaffold when it broke or collapsed.





Willful Violations

 It is not uncommon for protective system citations to be classified as willful serious, especially when no steps at all are taken to protect employees in the trench.

Citation 01 Item 001

Type of Violation: Willful Serious

29 CFR 1926.652(a)(1): Each employee in an excavation was not protected from cave-ins by an adequate protective system designed in accordance with 29 CFR 1926.652(b) or (c):

a) Construction Site, 159 Carl Eller Rd, Mars Hill, NC – where, on or about October 20, 2020, an employee was working in a 9-foot deep trench without the use of an adequate protective system. The employee suffered serious injuries when the trench collapsed while he was installing sections of 8' long and 15" diameter concrete storm water drainage pipe.

Date By Which Violation Must Be Abated:

Immediately Upon Receipt

Proposed Penalty:

\$28,000.00



Logging/Tree Felling SEP

- Most of these inspections fall under SIC codes 2411 for logging and 0783 for ornamental shrub and tree services.
- 34 inspections in FY2021, including 3 fatalities.
- 29.4% in-compliance
- Serious, Willful, or Repeat (SWR) violations identified on 47.1% of inspections.
- Most of the citations for these inspections for under the logging standard (1910.266), PPE standards, or the General Duty Clause.



Long Term Care SEP

- High injury and illness rates in the past were due primarily to sprains/strains and other ergonomic issues. That changed significantly in 2020 due to COVID.
- 46 inspections in FY2021, including 5 fatalities.
- 15.2% in-compliance
- Serious, Willful, or Repeat (SWR) violations identified on 56.5% of inspections.

Unlike the pre-pandemic years when bloodborne pathogens citations predominated, the main violations identified in FY2021 involved respirator fit testing, medical evaluations, and training.

Health Hazards SEP


- This SEP is an off-shoot of our general schedule targeting program that pulls random assignments from high hazard industries.
- Those assignments are then cross-referenced to NAICS codes likely to have silica, lead, asbestos, hexavalent chromium, and isocyanates (based on OSHA directives).
- 97 inspections conducted in FY2021
- 33% in-compliance, 54.6% have SWR violations
- These average 1.68 SWR items/inspection compared to 1.26 for all inspections – 33% higher.



Food Manufacturing SEP

- Covers establishments under NAICS 311 due to high injury/illness rates. In 2019, the DART rate was 2.1 for food manufacturing vs. 1.2 for all private industry.
- Assignments are generated via our normal targeting procedures, as well as through accidents and complaints.
- 51 inspections were conducted in FY2021, including two fatalities involving hydrogen sulfide exposure in a confined space.
- 17.6% in-compliance, 60.8% have SWR violations
- These average 1.86 SWR items/inspection compared to 1.26 for all inspections – nearly 48% higher.



Grocery Wholesalers SEP

- Covers establishments under NAICS 4244 due to high injury/illness rates. In 2019, the DART rate was 2.3 for grocery wholesalers vs. 1.2 for all private industry.
- 27 inspections conducted in FY2021
- 14.8% in-compliance, 55.6% have SWR violations
- These average 1.22 SWR items/inspection compared to 1.26 for all inspections.

Amputations SEP

- Our newest SEP. Started in FY2020 after a planning year in FY2019. This is a critical SEP. In FY2021, OSHNC received reports of the following:

 - 164 events of "amputation-digit"
 10 events of "amputation-limb"
 21 events of "pulled into machinery"
- The SEP includes accidents, complaints, and programmed-planned assignments.
- 162 total SEP inspections were conducted in FY2021
- 21.0% in-compliance, 74.1% have SWR violations.
- These average 1.72 SWR *items*/inspection compared to 1.26 for all inspections – 37% higher.
- Average penalty on these inspections is \$7875, over double the average inspection. 9.3% have been contested.



Case Law Language – Exposure

- The Act provides that guarding is required where employee exposure to a fall from a height over 6' is "possible." This includes the possibility of occasional, casual, or even inadvertent exposure. Budd-Piper Roofing, 216 NCOSHD at 327 The access test is predicated on the recognition that "[s]ome carelessness and negligence is anticipated and expected."
 - Commissioner of Labor vs. Flatiron-Lane, A Joint Venture, OSHANC 2011-5263

Amputation SEP – Targeting

- A very important part of this SEP is the targeting program. Unlike our general schedule targeting program that uses data from Federal OSHA, our Amputations SEP uses injury and industry data that is specific to NC.
- We've identified the industries (NAICS codes) with the highest incidence rate for amputations in NC and our PSIM Bureau pulls random assignments for inspection.

Amputation SEP – Targeting

- In FY2020 and FY2021, OSHNC Compliance conducted 100 programmed-planned inspections under this new Amputations SEP targeting program:
 - The in-compliance rate is 18.0%
 - 76.0% of inspections have identified SWR violations
 - The inspections are averaging 2.05 SWR items per inspection, which is 63% higher than the average inspection.
 - Only 1.0% of these programmed inspections have been contested.
